## Interpretation

"IAEA Regulations" means the Regulations for the Safe Transport of Radioactive Material, 1996 Edition of the International Atomic Energy Agency, Vienna.

"Regulations" means the Radiation (Control of Radioactive Substances) Regulations, Cap 303, Laws of Hong Kong.

The licensee shall possess a set of the Radiation Ordinance, Regulations and IAEA Regulations for reference to the following conditions.

## Conditions

These licence conditions may be revised by the Radiation Board to protect public interests in accordance with the spirit of the Radiation Ordinance.

1. This licence permits the possession, conveyance and storage of the radioactive substance(s) in quantities not exceeding the levels stated below.

2. Any activities involving the radioactive substance(s) prescribed in this licence, including handling and safe keeping, shall be carried out under the direct personal supervision of at least one of the following person(s) in accordance with Regulation 32.

The licensee shall obtain the approval of the Radiation Board prior to appointment or replacement of the above supervising personnel(s).

3. All persons engaged in the handling and conveyance of the radioactive substances are subject to:
  - (a) Regulation 10 - Precautions with regard to exposure;
  - (b) Regulation 15 - Presumptions as to exposure to radiation;
  - (c) Regulation 17 - Medical examination and inquiry in cases of suspected over-exposure to radiation;
  - (d) not be under the age of 18 years.
4. Import of radioactive substances is not permitted under this licence.

5. Conveyance of radioactive substances shall be subject to:
  - (a) IAEA Regulations;
  - (b) Regulation 7 - Conveyance of radioactive substances on vehicles or vessels;
  - (c) at least one of the persons named in Condition 2 shall personally supervise each conveyance of radioactive substances;
  - (d) each conveyance of radioactive substances shall be carried out in accordance with a permit granted under Regulation 7(1). Application for permits for conveyance shall be submitted to the Radiation Health Division, Department of Health, 3/F, Sai Wan Ho Health Centre, 28 Tai Hong Street, Sai Wan Ho, Hong Kong (Tel: 3620 3771).
  
6. Storage of radioactive substances shall be subject to:
  - (a) Regulation 8 - Storage;
  - (b) Regulation 24 - Provision of storage safe in certain cases;
  - (c) any storage safe designated for the storage of radioactive substances shall not be used to store other substances;
  - (d) the store room shall be classified as a control area where no persons other than those registered in accordance with Regulation 11 shall have access;
  - (e) radioactive substances inside the store room shall be so shielded that the radiation to any person inside the room shall not exceed 10  $\mu\text{Sv/h}$ ;
  - (f) the radiation level in any accessible location outside the store room shall not exceed 1  $\mu\text{Sv/h}$ ;
  - (g) an inventory of the radioactive substances shall be kept inside the storeroom where they are stored and shall be kept up-to-date at all times.
  
7. The licensee shall not subcontract the conveyance of radioactive substance to any other person.
  
8. The use of the radioactive substance(s) is not permitted under this licence.
  
9. Purchase, sale and transfer of radioactive substances, except those collected for disposal from customers, are not permitted under this licence.
  
10. The disposal of radioactive wastes shall be subject to:
  - (a) Regulation 9 - Disposal of radioactive wastes;
  - (b) Regulation 25 - Disposal and transport of radioactive wastes;
  - (c) waste packages containing radioactive substances shall be returned in accordance with the IAEA Regulations to the manufacturer.
  - (d) quarterly returns shall be made to the Radiation Board of detectors collected for disposal, giving details of customer's name, address and Radiation Board Licence/exemption number, and the number and activity content of all detectors disposal of during the period and the balance remaining in the storeroom.

11. The licensee shall be subject to:

- (a) Regulation 4 - Licence;
- (b) Regulation 5 - Licence to be exhibited.
- (c) the satisfactory compliance with the "*Basic Safety Standards for Protection Against Ionising Radiation and for the Safety of Radiation Sources*" issued by the Radiation Board.

Emergency Action

- (a) In case of FIRE or HUMAN CASUALTY, call Fire Services (999).
- (b) In case of ACCIDENT or LOSS OF RADIOACTIVE SUBSTANCE :

In all cases, the licensee shall notify the Radiation Board in writing within 48 hours.
